In addition to this, the western basins (i.e. EPA 1 and EPA 21) were being used to treat runoff from intermittent minor rainfall events occurring during the month of June 2019. Hence the lower western basin (i.e. EPA 21) overflowed on the days when total suspended solids exceedance was recorded. Kimbriki will continue to maintain sediment basins in low flow periods to prepare for impending rainfall. This includes supplementing stormwater with town water as required for dust suppression activities. Kimbriki perform daily inspections of sediment controls and proactively maintain controls by all means practicable to ensure potential for suspended solids discharge is minimised.</p>
