★ Asbestos

Kimbriki accepts asbestos in packages double-bagged or double-wrapped, and sealed in heavy duty builders plastic at least 120UM thick – package limit 20kg each and unloaded by hand. Transporters with loads over 100kg must report to the EPA using: Integrated Waste Tracking Solution www.kpmgorigins.com/iwts

★ VENM - Virgin Excavated Natural Material

Natural material such as clay, gravel, soil, sand and rock fines, which has been excavated from an area that is not contaminated VENM must not contain any contaminants such as grass, concrete, bricks, broken pipes, building material, sulfidic ores or any other foreign matter. All VENM loads delivered for disposal at Kimbriki must be accompanied by a signed NSW EPA VENM Certificate (download at kimbriki.com.au What Can I Bring/VENM).

★ Globes & Fluorescent tubes

Must be fully intact and removed from packaging. Maximum of 10 items per customer. Fluorescent tube lengths up to 4ft (1.2m) are accepted.

★ Embedded Batteries

Domestic quantities only, up to 60 litres or 20kg. Large or unusual products: please phone ahead to see if they can be accepted.

★ Clothing

Donations must be in good condition. Clean wearable clothing items, accessories, household manchester (towels, bedsheets, bedspreads, blankets). If the items are not suitable for re-use, mixed waste rates apply.

★ Gas bottles with valve

– Up to 9kg maximum size. Limit of 2 per customer per day. Place upright in the container provided.

★ Gas bottles without valve

– Limit of 10 per customer per day. Canisters containing carbon dioxide (CO2), Butane, Propane or Nitrous Oxide N2O. Other contents not accepted.

★ Fire extinguishers – up to 9kg maximum size. Limit of 2 per customer per day. Types include: Water, Foam, Dry Powder ABE or BE, Carbon Dioxide ("CO2") or Wet Chemical. NO Yellow Halon extinguishers permitted - check with your local fire station for disposal.

★ Paint

Limit of 100 litres is measured by the size of the container not the amount of paint inside. For a list of what is accepted, see www.paintback.com.au.

★ E-waste

For a list of what's accepted, see techcollect.com.au or kimbriki.com. Toners must be removed from items.

★ Fridges, Freezers & Air Conditioners

Must be de-gassed, or the charge per unit applies. Free of charge with proof of de-gassing by a licensed technician who holds a current ARC Refrigerant Handling License.

★ Resident Vegetation Drop off at Kimbriki.

For residents of Northern Beaches or Mosman Councils only

1. Vehicles are limited to cars, station wagons, utes, family vans or trailers with proof of residency.
2. Trade vehicles are excluded. Arrangements can be put in place to register a resident's trade vehicle for occasional use only. Visit Kimbriki Reception for details.
3. Residents are entitled to one vegetation drop-off of up to 300kg per day and a total of 4 tonnes per financial year.
4. If your load is over 300kg you must pay for the portion over at the vegetation tonne rate.

★ Resident Polystyrene (EPS) Drop off at Kimbriki.

For residents of Northern Beaches Council only

1. Monthly drop off for residents, on the published day of event only.
2. Domestic quantities up to 240L (equivalent to volume of your green vegetation bin).
3. Polystyrene must not be contaminated with dirt, soil, tape, concrete, food, labels, plastic cardboard or ink printing.
4. 100% clean, white and dry expanded polystyrene (EPS) only, If you can bend it and it snaps then it is EPS. only.
5. Bean bag beads are not accepted.

Weighbridge

All vehicles must ENTER via Weighbridge A or B and EXIT via Weighbridge C or D even for no charge transactions. Failure to stop at exit will prevent your re-entry to site and start debt recovery action if required.

CCTV and Licence plate recognition

The Kimbriki site operates under CCTV and all vehicle licence plate numbers are recorded at the weighbridges.

Loading and unloading

All loads must be unloaded by the customer. Please bring appropriate resources to unload. Once waste has been dropped, charges will apply. Waste cannot be retrieved once it has been dropped. Crane use on Kimbriki site is only permitted with prior arrangement. Please contact the Administration Office on 9486-3512.
